Program Financials

In booking our usual 6 summer programs, we found that presenters have significantly raised their prices. Some doubled their prices right out of a range that we could afford. There is not enough money in the program line of the budget to cover this. In order to keep all 6 of these programs, I would like to request an additional \$1,000 be added to the Program line in the budget.

Windows Project

She got a bid from another glass vendor for \$3,000 and she will hire a local contractor to do the installation.

Open Meeting Policy Changes:

From SALS:

The Governor has not lifted the declaration of emergency. However, she may not extend it. Your board has until June 8, 2022 to comply with the new videoconferencing requirements. The board of trustees would need to adopt a resolution authorizing such remote attendance, and establish written procedures that set forth what is determined to be "extraordinary circumstances". These circumstances can include disability, illness, caregiving responsibilities or any other significant or unexpected factor or event which precludes the member's physical attendance at such meeting.

From NYS Committee On Open Government

- Q. Are there any required steps that a public body or local public body must complete before it can permit its members to participate in an open meeting from a private location, citing "extraordinary circumstances" as described in the new § 103-a of the OML?
- A. Yes. In all cases, we understand that the new Law requires that every public body must conduct a hearing before taking advantage of the "extraordinary circumstances" described therein. The Law provides, among the other listed prerequisites, that a "public body may, in its discretion, use videoconferencing to conduct its meetings pursuant to the requirements of this article . . . where . . . the Chapter 56 of the Law of 2022 (Q&A continued) Page 2 of 4 governing board of a county, city, town or village has adopted a local law, or a public body has adopted a resolution, or the senate and assembly have adopted a joint resolution, following a public hearing, authorizing the use of videoconferencing." While the required hearing is most likely also a meeting subject to the other requirements of the OML, it is possible that additional legal requirements imposed by different statutes will also apply to any such hearing.
